- Positive alternative for a local government model of the future
- Promotes an approach which is contrary to Enabling/Commissioning model
- APSE's contribution to assist councils in talking budget reductions



- Research conducted by De Montfort University
- Engaged members/officers in research
- Report envisages wider role for councils/services
- Report promotes key principles:
  Democratic Accountability
  Stewardship
  Public Value
  Social Justice
  Civil Entrepreneurship





- Challenges hollowing out councils/services
- Need to retain core capability to provide services
- Avoid "market place" solutions
