Government Procurement Card [GPC]

- GPC Framework covers Purchasing & T&S cards until January 2010
- Central role in helping public sector achieve efficiency savings
- £28 savings figure equates to £1.3m in 2007
- Spend approx. £1bn pa 1000+ Organisations -117k+ cards

Government Procurement Card [GPC]

- Fully endorsed by NAO and HMT
- Contributes to a range of Government policies on efficiency, modernisation, sustainability and e commerce
- Framework available to all public sector Central & Civil Government, Local Authorities, Emergency Services, Health, Higher & Further Education, Schools
- Government Merchant Acquiring Framework

Purchasing Cards and Local Authorities

- Initial National Procurement Strategy by 2005 for low value purchases every council should be making appropriate use of a procurement card or a suitable electronic alternative
- Recent RCE survey showed only 121 [of 268 respondents = 45%] had begun implementing a P Card scheme
- National Procurement Strategy for Local Government Final Report (April 2008) – 51% of councils using a procurement card
- Local Government Purchasing Card Solutions Project by March 2010 aims to reduce invoice volumes by 20% - 2.16m invoices -£60.48m

Benefits of GPC

- No card or transaction fees
- Replace inefficient traditional procurement
- Produce valuable management information on spend
- Reduce paper more environmentally friendly
- Promote greater financial visibility and accountability
- Enables Organisations to redeploy staff to more valuable tasks

ogc buying.solutions

- Empowers employees giving accountability and responsibility
- Meets Government prompt payment agenda suppliers are paid typically within 2-4 working days
- Tried and tested Visa solution accepted globally

GPC usage

- Can be used for low value purchasing and/or travel related spend
- Face to face/over the counter/card present transactions
- Card not present transactions internet web sites/phone
- Lodged card with suppliers
- Embedded within eP2P applications
- Lodge Card with Business Travel Agents

- Travel & subsistence
- Couriers & taxis
- Catering
- Temps and agency staff
- Training courses and Conferences
- Buildings supplies, repairs and maintenance

- Office flowers, plants, catering
- Domiciliary care

- Card spend interface with GL
- Visa card capability and recruitment of suppliers to card acceptance
