




## Scottish fleet landings 2008.

# **Scottish Shellfish Sector**

Major Species: Langoustine, Crab, Lobster, Scallops

- Langoustine: The most valuable species to the Scottish industry.
- Varied fishery:
  - East and West coasts
  - creel and trawl caught



- Two fisheries MSC certified (trawl & creel)
- Two more in the process









## **Scottish Shellfish Sector**

Crab & Lobster: Caught mainly on West of Scotland; outer islands and Orkney/Shetlands

- High quality, clear deep, cold, unpolluted waters
- Passive methods: Creel and pot caught.
- Low impact, small boats.
  - Very important for small rural communities

#### Scallops: mainly King Scallop

- Inshore and offshore fishery
- Hand dived & mobile gear
- Scottish industry leads on innovative gear improvements to reduce environmental impact.









# Scottish demersal (whitefish)

- Major Species: Haddock, Monkfish, Cod, Saithe, Whiting, Hake.
- Haddock principle whitefish species
  - (North Sea & Rockall)
  - NS In MSC Assessment
- Monkfish high quality & value
  - Precautionary catches advised
  - Scottish fleet working to enhance data and knowledge of fishery
- Cod North Sea now in recovery
  - Allowable catches now starting to increase
  - Scottish industry leading Europe in new measures for recovery









## Scottish pelagic sector



- Major Species: North sea Herring & NE Atlantic Mackerel
- Caught by a designated fleet of 25 vessels
- Boats large, modern, efficient, automated, but highly regulated.
- Whole fleet works to best practice guidelines
  - Voluntarily use pre-catch sampling in mackerel fishery



### Both fisheries are MSC certified.

## **Industry Diversification:**

- Scottish industry keen to promote other species not widely associated with Scotland.
  - E.g. Megrim, lemon sole, halibut, mussels, velvet crab
- Many fisheries are dynamic and sometimes rapidly evolving or changing.
  - E.g. Hake, John Dory, razor clams







### **Responsibly & Sustainably caught**

- Fisheries management; seafood retailers; restaurants, foodservice, wholesalers, & fishermen being challenged on all impacts of fishing.
- So what is Scotland doing to meet these challenges?
- Plenty!
  - Seafish Responsible Fishing Scheme / Fishing for Litter / Observer programmes/ MSC / Gear advancements / SCCS





## **Supporting Responsible Fishing**



An independently audited UK mark of good practice by a vessel skipper and crew in their fishing operations.

- Scottish boats pioneered the scheme.
- •The 1st & 100th vessels to gain accreditation were Scottish.
- Now over 140 Scottish boats fully certified





# Cleaning up

Fishing For Litter

www.fishingforlitter.org

- Marine litter estimates:
  - 15% floats and gets washed ashore
  - 15% floats remains suspended in water
  - 70% sinks to seabed
- Clean-up campaigns only target shore material
- Fishing for litter Scheme launched in Scotland in 2005.
- Active participation from 10 ports and 110 boats
- Fishing vessels only type which can actively help tackle this issue at sea
- 2<sup>nd</sup> phase to target
  - all Scottish designated ports (16)
  - Expand to 200+ boats





## Scottish conservation credits scheme (SCCS)

### From 2009


- A key tool of the Scottish management system
  - now applies to all Scottish areas of the cod recovery zone
- Developed to include:
  - Real Time Closures (RTC's) & Seasonal Closures
  - Amber Avoidance Areas
  - Use of highly selective gears
    - E.g OrkneyCod avoidance trawl

Original target **140** for the year





## **Observation programmes**

- Scottish Government is funding 4 additional full time observers for 2 years
- Target 500 observed days at sea/yr over the 2 years
  Why?
- The data gathered over the project duration will vastly improve and strengthen the scientific knowledge of Scottish demersal fisheries.
- In addition CCTV: now being trialled by demersal NS boats (tool to reliably record total catches / incentivise fishermen /alternative method monitoring)



## **Sustainable Accreditation**



- The Marine Stewardship Council (MSC) promotes responsible & sustainable fishing
- The MSC has developed an environmental standard for sustainable & well-managed fisheries
- Scottish fisheries have engaged with the MSC process for many years. Currently 5 certified fisheries in Scotland
  - Mackerel
  - Torridon Langoustine
  - North sea Herring
  - Atlanto-Scandian Herring
  - Stornoway langoustine





## **Sustainable Accreditation**

# •In Assessment:

- -North Sea Haddock
- -North Sea Langoustine
- -Clyde Langoustine
- Industry considering other commercial species of high importance
- Industry groups formed to proceed
- •Process is well under way
- •Hope to see Scottish NS Haddock, Langoustine MSC certified by August (?)


