What are Wakefield doing differently?

Background

- Wakefield MDC is a local authority situated in West Yorkshire.
- We cover a semi rural area of 350 square kilometres.
- Wakefield has a fleet size of approx 700 vehicles.
- Employing in the region of 2000 drivers (fleet).
- One of the first local authorities to employ a Fleet Enforcement Officer.

Fleet Enforcement Role

- On road enforcement (fleet driver spot checks).
- Gate checks (early morning driver checks).
- Awareness training for drivers.
- Depot audits (paper trails).
- Workshop quality controls.
- Legislation up-dates.

Enforcement Team

2005 team increased to meet demands:

- Driver hours training
 - Digital Tachograph training.
 - MIDAS / PATS / Emergency evacuation.
 - Develop & deliver a driver assessment programme for fleet drivers.

APSE Submission “Reducing the Risk”

- Submission based on the driver assessment process.
- Getting something of this nature off the ground can be difficult:

“It’s a method of selecting you for redundancy”.

“People making a job for themselves”.

“Management making life difficult”

“I won’t be doing a driver assessment”

Reducing The Risk

Under the watchful eye of the union we developed our assessment process.

- Enforcement officers trained to driver assessor standards (including an advanced driving test for good measure)
- Routes planned to include all types of roads/obstacles
- How often should the assessments be taken?
- Who's going to be first?

Driver Assessment

What Generates A Driver Assessment?

- New recruitment where **any** driving is a requirement.
- New driver's, (current employees).
- High risk drivers, (numerous accidents/penalty points).
- Five Yearly cycle.
- Future legislation.

Reducing The Risk

How can we ease this radical new idea in?

We thought it would be a good idea to develop a road show and take this around the authority.

Including the latest facts and figures from ROSPA

- (the number of road deaths which occur nationally while driving for work)
- Our commitment to occupational road risk
- Our duty of care for our drivers and their colleagues.

The Driver Assessment Process

This consist of the following.....

- **Meet and greet the driver.**
- **Completion of a pre-assessment form.**
- **Eye sight check (number plate recognition at 20.5 meters).**
- **Daily vehicle walk round check.**
- **One hour drive.**
- **Reverse manoeuvre.**
- **Highway Code questions.**
- **Debrief and feed back.**
- **Assessment form and permit completion.**

Tractor & Ride on Mower Additional Driver Assessment

- It was decided to carry out Additional assessments on vehicles such as Tractors and ride on mowers.
- The drivers road craft has already been assessed during his one hour assessment drive.
- An additional assessment course was set up based on previous assessments carried out by outside contractors.

- These Additional Assessments Consisted of the following.....

Tractor & Ride on Mower Additional Driver Assessment

- Vehicle familiarisation.
- Safe start Procedure.
- Safe Stop Procedure.
- Forward manoeuvre.
- Reverse manoeuvre.
- Slalom manoeuvre.
- Safe Parking.



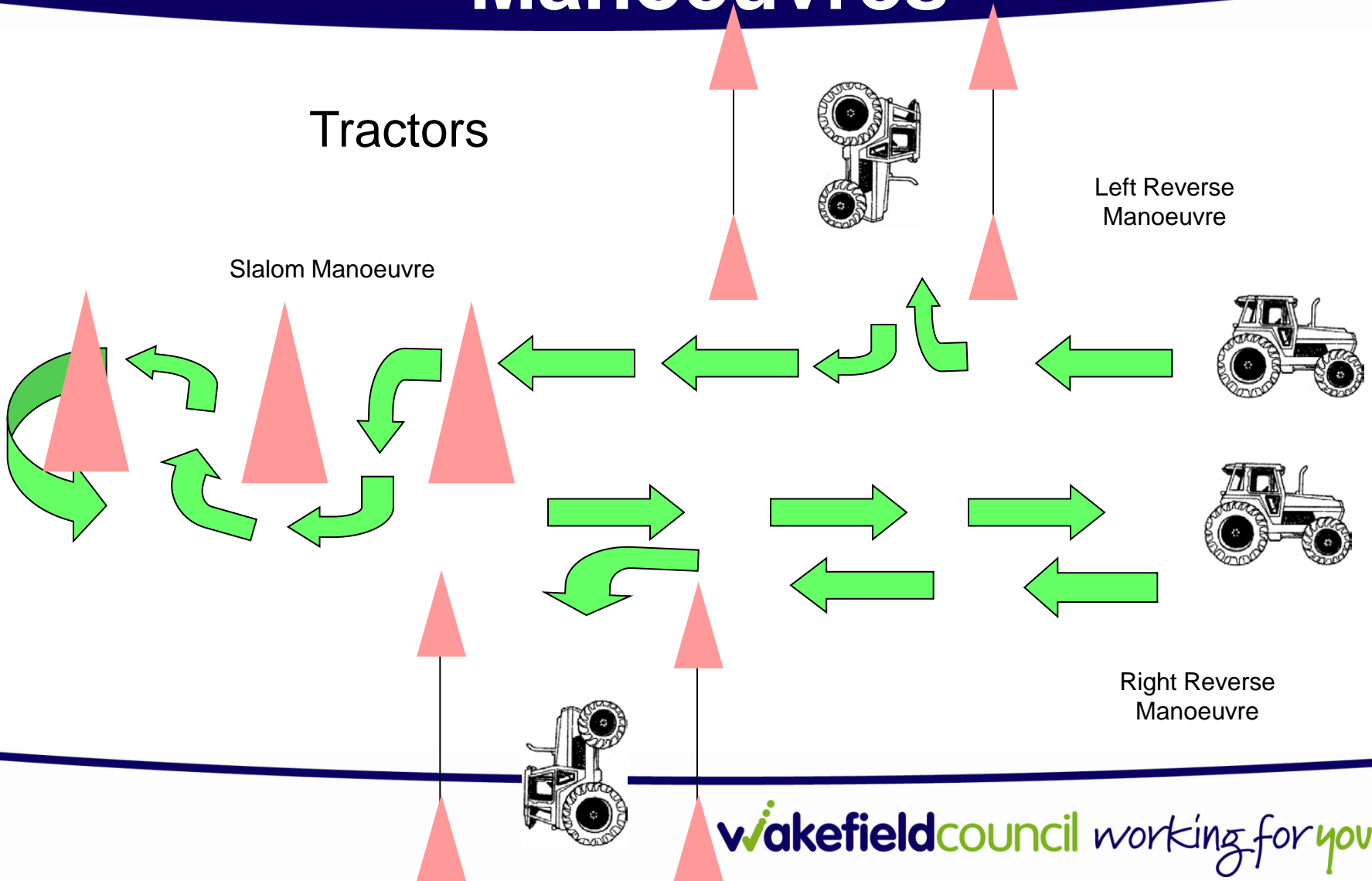





















Right Reverse

- On completion of the additional training a permit will be issued.

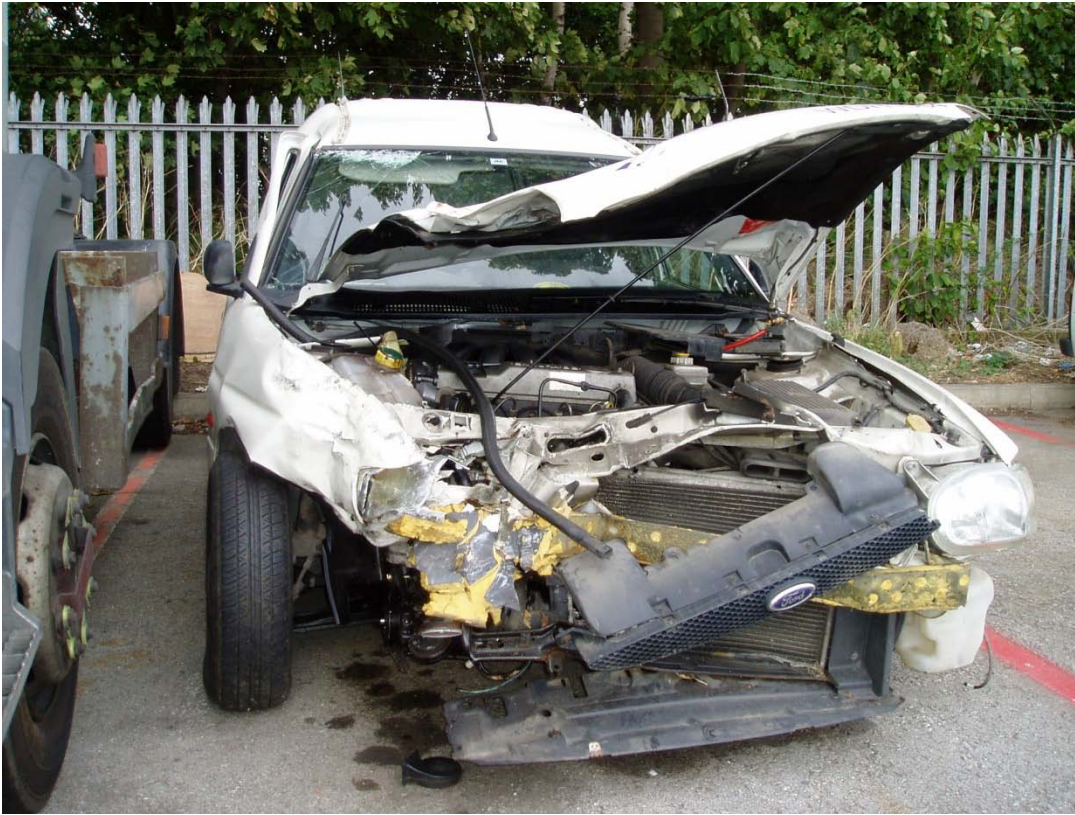
