The Key Drivers

- Revised Waste Framework Directive
 - Member States shall take measures to promote high quality recycling and, to this end, shall set up separate collections of waste where technically, environmentally and economically practical and appropriate to meet the necessary quality standards for the relevant recycling sectors







Waste (Scotland) Regulations 2012

- **Key Themes:-**
 - Maximise quantity and quality of materials for recycling
 - Move residual waste management up the hierarchy
 - Drive operational and cultural shift from waste to resource management for business and householders
 - Create market certainty to support investment

Draft Regulations laid before the Scottish Parliament under paragraph 2(2) of Schedule 2 to the European Communities Act 1972, for approval by resolution of the Scottish Parliament.

ENVIRONMENTAL PROTECTION

The Waste (Scotland) Regulations 2012

Made - - - -Coming into force - -

The Scottish Ministers make the following Regulations in exercise of the powers conferred by section 2(2) of the European Communities Act 1972(a) and all other powers enabling them to do

In accordance with paragraph 2(2) of Schedule 2 to that Act(b), a draft of these Regulations has been laid before and approved by resolution of the Scottish Parliament.

Citation, commencement and extent

1.-(1) These Regulations may be cited as the Waste (Scotland) Regulations 2012, and come into force on the day after the day on which they are made.

(2) These Regulations extend to Scotland only

Amendment of the Environmental Protection Act 1990

- 2.-(1) The Environmental Protection Act 1990(e) is amended as follows
- (2) In section 29(5A) (preliminary)(d), after paragraph (b) insert-

"(ba) "separate collection" means that waste is presented for collection, and collected,

(i) dry recyclable waste is kept separate from other waste;

Paragraph 1(d) of Schedule 2 to the European Communities Act 1972 has been modified by section 47 of the Criminal Proceedings etc. (Reform) (Scotland) Act 2007 (asp 6) so that the functions conferred under section 2(2) can be Criminal revocueing est. Concomit (occumin) ext. 2007 (sap f) so until the functions contribute to section 2.2 can be exercised to create an offence purishable on summary conviction by a fine of up to the statutory maximum. The functions confirmed upon the Minister of the Crown under section 2(2), insofar as within devolved competence, were transferred to the Scotish Ministers by virtue of section 3 of the 1998 Act.

Schedule 2 has been modified by puragraph 5 of schedule 3 to the Interpretation and Legislative Reform (Scotland) Act 2014(Scota 10).

Waste (Scotland) Regulations 2012

- Specific Measures:-
 - Businesses to present dry recyclables (metals, plastics, paper, card and glass) and food waste of >50kg/week by 1st Jan 2014. Those producing <50kg exempt until 1st Jan 2016.
 - Local authorities to provide householders with a collection for dry recyclables (1st Jan 2014) and food waste (1st Jan 2016)
 - Ban on materials collected for recycling going to landfill or incineration.
 - 1st Jan 2016 ban comes into force to prevent food waste going to drain or sewer.

Draft Regulations laid before the Scottish Parliament under paragraph 2(2) of Schedule 2 to the European Communities Act 1972, for approval by resolution of the Scottish Parliament.

- 2.—(1) The Environmental Protection Act 1990(c) is amended as follows.
- (2) In section 29(5A) (preliminary)(d), after paragraph (b) insert-
 - "(ba) "separate collection" means that waste is presented for collection, and collected, in a manner that ensures that—
 - (i) dry recyclable waste is kept separate from other waste;

S. 1.2000/323, 2005/22, 2009/247 and 2011/226. (6) Subsection (5.0) was inserted to 8.5. 2. 2. 2011/26.


